- 2. One expert will talk about sustainable remediation principles. Then work in groups will be formed on the Zachem study case. Participants will get general information and they will have to perform tasks given by expert (each group different field or phase of remediation process).
- 3. Choose different field of remediation process and work in groups on different subject.
